### TERMS & CONDITIONS

1. Donated trees and benches become the property of the City of Regina.
2. Donated items are intended for the use and enjoyment of the public.
3. The City of Regina will attempt to accommodate the requested location as closely as possible for new Legacy bench installations; however, reserve the right to make the final decision on placement based on factors such as underground utilities and on-going maintenance.
4. The City of Regina will maintain donated benches for a ten-year period. At the end of ten years, the City reserves the right to relocate or remove benches & plaques without notice.
5. Tree applications approved prior to September will be installed that year, weather permitting.
6. The City of Regina will complete care-to-establishment for legacy trees for a three-year establishment period. Following the establishment period trees will be maintained in accordance with the City of Regina's Urban Forest Maintenance Program.
7. Installation of all other legacy items cannot be specified due to weather, supply of items, special events, and ongoing construction and maintenance activities.
8. The City of Regina reserves the right to relocate or remove benches & plaques without notice due to operational requirements.
9. No additional plaques or personal items will be accepted. The City of Regina reserves the right to remove and dispose of all memorabilia found attached to or around the donated item.
10. The City of Regina is not liable for any damages or losses to legacy dedications resulting from theft, vandalism, mishaps or natural causes. Please consider the location of the bench, keeping in mind they are in public spaces.
